4. All general and specific requirements identified in FY14 SRIP remain in effect unless otherwise stipulated in this Education Incentive Operational Message (EIOM).

#### a. Reenlistment/Extension Bonus (REB):

(1) Three year REB replaced by two year REB: (Enclosure 1)

(3) Extension window is expanded from 365-91 days to 365-1 days prior to ETS.

b. Enlisted Affiliation Bonus (EAB):

(1) MOS list will be utilized to identify incentivized MOS positions in the ARNG. Position must be vacant and the Soldier must be the primary slot holder in order to receive the incentive (Enclosure 2).

(4) Six year Non-DMOSQ EAB: (Enclosure 1)

c. Prior Service Enlistment Bonus (PSEB):

(3) Six year Non-DMOSQ PSEB implemented. Payment amounts: (Enclosure 1). The following incentives are not authorized with this incentive regardless of the vacancy tier level:

(a) Montgomery G.I. Bill Selected Reserve (MGIB-SR)

(b) Student Loan Repayment Program (SLRP)
